

Conversion of Non-Equity Security	
Q1	How do I know whether I can submit my conversion of XYZ Berhad warrants via TIIH Online?
A1	<p>Login to TIIH Online with your user ID and password <i>(if you are already a user of TIIH Online, otherwise you are required to register as a new user before proceeding)</i>.</p> <p>Go to “Filtered by Corporate Exercise Type”.</p> <p>Select “Conversion of Non-Equity Security”.</p> <p>A list of company which allows its security holders to do e-conversion will be displayed. If XYZ Berhad warrants conversion is listed therein, this confirms that you can submit e-conversion of your warrants here.</p>
Q2	How do I convert and pay for my XYZ Berhad warrants conversion in TIIH Online?
A2	<p>Go to TIIH Online website at https://tiih.online</p> <p>Log in with your user ID and password <i>(if you are already a user of TIIH Online, otherwise you are required to register as a new user before proceeding on)</i>.</p> <p>Select the company name (“XYZ Berhad”) and corporate exercise type (“Conversion of Non-Equity Security”).</p> <p>Read and agree to the Terms & Condition and Declaration.</p> <p>Complete the Conversion/Exercise Form with the required details.</p> <p>Check the conversion details and insert the amount payable and confirm.</p> <p>Confirm the total amount payable.</p> <p>Proceed to pay the amount via Maybank2u or any Financial Process Exchange (FPX) participating bank which you have an internet banking account.</p> <p>Once payment process is completed, go to Application History to download and print your e-conversion form for your record.</p> <p>You will also receive an email from TIIH Online acknowledging receipt of your successful submission of e-conversion of warrants.</p>
Q3	Do I need to submit the hardcopy of the conversion form and proof of payment if I have completed the conversion of warrants via TIIH Online
A3	You do not need to submit the hardcopy of the conversion form.
Q4	When will the new shares be credited into my CDS account after I have completed the e-Conversion?
A4	The new shares will be credited into your CDS account within 8 market days from the date you have submitted your conversion.
Q5	Where can I get a copy of the conversion/exercise form?
A5	<p>Log in with your user ID and password <i>(if you are already a user of TIIH Online, otherwise you are required to register as a new user before proceeding on)</i>.</p> <p>Select the company name (“XYZ Berhad”) and corporate exercise type (“Conversion of Non-Equity Security”).</p>
